Have you ever wanted to sell your crafts, specialty gifts or gift certificates in a mall during the *busy holiday shopping season*? Ever considered marketing your business to mall shoppers? Here's your opportunity **AND at an affordable price!**

- DATES & TIMES:** Show - Dec 14-16 (Fri-Sun) - Fri, 10a-10p, Sat, 9a-11p; Sun, 10a-10p (Show hours are subject to change.)
Check-In - Dec 13 (Thurs) between 8:45p-10p; Set-up begins after the mall closes at 10p.
- LOCATION:** The Mall at Tuttle Crossing, 5043 Tuttle Crossing Blvd, Dublin; spaces located throughout mall.
- ITEMS ACCEPTED:** Art, craft, unique & specialty gifts, home-based business products, professional services, etc.
- DISPLAY FEE:** \$350/three days. Space accommodates 1 table only (6' or 8' table, must specify below what size you are planning to bring). Exhibitor provides own table and table cover. Table cover must drape your table on all 4 sides and to the ground with black or dark navy blue cloth table covers. A limited number of 6ft tables with covers are available, until gone. A limited number of 8'x10' spaces may be available closer to the show date, call to inquire. To sell Gift Certificates only, add \$100.
- ELECTRIC:** Limited spaces with electric are available, apply early.
- PAYMENT:** \$100 deposit due with application (**applied to booth fee**); balance due by Friday, November 16th
Cancellation fees - \$100 fee if cancelled before Nov. 16th and full booth fee after Nov. 16th.
- MISC. INFO:** Display must be manned all mall holiday hours. If requesting a table, exhibitor may be responsible for moving it from staging area to space. Show marketing includes mall signage, event listings, flyers, press releases, and more. Exhibitor must have either a Franklin County or Ohio Transient Vendor's License. All other show rules and regulations will be provided with confirmation letter and will apply. Commercial exhibitor pricing is different and requires a separate application, please call to inquire.
